

## Privacy Notice

In compliance with the Federal Law of Personal Private Information Protection (Ley Federal de Protección de Datos Personales en Posesión de los Particulares) (the "Law") and its Regulations (the "Regulations"), Corporación Inmobiliaria Vesta, S.A.B. de C.V. and its subsidiaries and affiliates (referred as "Vesta") located at Paseo de Tamarindos No. 90, Torre II, Piso 28, Colonia Bosques de las Lomas, C.P. 05120, Ciudad de Mexico, consider hugely important the privacy of information and for that reason, publish this Privacy Notice (the "Notice").

The security of your information is very important for us and we are committed to protect the information that collect from you; for this, we have implemented measures of technical security, organizational and legal necessary, to protect the misuse or alteration of the information collected and will not use the information provided by you for different purposes herein described or within the document in connection of the legal relationship between you and Vesta; However, nor data transmission via internet or another wireless network is completely secure; for that reason, the transmission data through such media, you expressly assumes the risk of such communication media represents for the information transmitted.

Derived from the commercial relationships that may exist between you and Vesta, it may collect information relative to you, and/or your company and/or related parties. Our records are based on information provided directly by you, information that is available on public records and information provided by third parties who have expressly authorization to do so, either to analyze any possible business transaction with Vesta, a possible labor relationship, a possible contractual relationship of any kind, and/or to comply with any legal requirements that Vesta may be under in Mexico and/or in any other jurisdiction. This means that personal data held in Vesta's data, may be transferred or shared to any of their companies affiliates and/or subsidiaries, and even third national or foreign people; unless you as holder expressly declare the opposition according to the "law".

National or international transfers of data may be carried out without the consent of the owner, among other cases, provided that the transfer: (i) is made to the subsidiaries or affiliates under the common control of the responsible party, or to a parent company or to any company in the same group as the controller that operates under the same internal processes and policies; (ii) it is necessary by virtue of a executed agreement or to be celebrated in the interests of the holder, by the responsible party and a third party; And (iii) is accurate for the maintenance or fulfillment of a legal relationship between the company you represent and Vesta.

Only for the purpose of the exceptions provided in the Article 37 of the Law, Vesta is responsible for giving confidential treatment to the personal data that may obtained by third parties, either those that have been directly provided or obtained by different means, and will take the necessary measures for their safety and the legitimate, controlled and informed management of any personal data by those third parties, by their personnel, employees, dependents, consultants, associates, affiliates, subsidiaries or any other person that may have a relation and that could have access to the personal data.

Your information will be kept in Vesta's data base, to which only Vesta's employees have access. Outside of Vesta, your information may be disclosed (i) when an authority with jurisdiction over Vesta requires it under the formalities that the law demands, (ii) to service suppliers, only when it is necessary that those suppliers work for Vesta, as in the case of nesting of web sites, data storage, lawyers, auditors, etc.

This document is the notice to which the Law and the Regulations refer to, so when you provide Vesta with any personal data, you expressly waive to the exercise of any legal action derived from the lack of that Notice.

The company be represented by you is entitled to withdraw your consent at any time, as well as to access to your information and request to be rectified or deleted from our data base and to oppose the processing thereof, by means of a written request, which must be submitted at the address above, aimed at "Legal Director"; On the understanding that any processing of personal data will be subject to the consent of the owner, except by provided by the Federal Law on the Protection of Personal Data held by Individuals.

When is necessary, Vesta may retain a minimum of information according with those legal requirements applicable, in order protect Vesta's interest; with the understanding of that information will be retained as confidential information and only for the sole purpose to comply with applicable legal obligations.

Vesta keeps the right to change, modify, supplement or alter, in any time the present notice, in that case, is will make of the knowledge of the public through the Internet page <http://www.vesta.com.mx/> or of any of the media that stablish the corresponding legislation. The recent review of this notice was led to place on January 1<sup>st</sup>, 2019.

The changes to this policy of privacy will not affect the use of the information previously provided.
